BACKGROUND

This report is distributed in accordance with Section 284 of the Municipal Act, 2001. The purpose of this report is to provide a statement of remuneration and expenses paid to Council and board committee members in the calendar year of 2018.

Each year the Treasurer reports on Councilor remuneration. Under the s.284(1) of the Act:
The Treasurer of a Municipality shall in each year provide to the Council of the Municipality an itemized statement on remuneration and expenses paid in the previous year to:

- a) *Each Member of Council in respect of his or her services as a Member of the Council or any other body, including a local board, to which the member has been appointed by Council or on which the Member holds office by virtue of being a Member of Council; and*
- b) *Each person, other than a Member of council, appointed by the municipality to serve as a member of any body, including a local board, in respect of his or her services as a member of the body. 2001, c. 25, s. 284 (1).*

Under Section 284 (4) of the Act it should be noted that:

(4) Despite the Municipal Freedom of Information and Protection of Privacy Act, statements provided under subsections (1) and (3) are public records.

Pursuant to the Municipal Act, 2001 the treasurer of a municipality shall in each year provide to the council of the municipality an itemized statement of remuneration and expenses paid in the previous year to, (a) each member of the council or any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council. 2001, c.25, s.284 (1).

Committee and Board Members were appointed by bylaw, and the remuneration and expenses were authorized with the adoption of the Budget and with the passing of the Tax Rate By-Law. 2001, c.25, s.284 (2).

Under the Municipal Freedom of Information and Protection of Privacy Act, statements provided under section (1) are public records. 2001, c.25, s.284 (4)
