6. Public Meeting

6.1 Public Meeting No. 1.

The purpose of this public meeting is to consider an application to change the zoning on the subject lands to satisfy a condition of consent for a surplus farm dwelling severance. (8319 Century Drive – 1985626 Ontario Ltd.)

6.1.1. Motion to open the public meeting.

Moved by Councillors Hipple and Kennes:

That: the public meeting to consider a rezoning application for 8319 Century Drive – 1985626 Ontario Ltd. Be hereby opened. **Carried.**

6.1.2. Report to be presented by the Planner.

Director Matt Stephenson introduced Tim Williams Planner, presenting the planning report in respect to this application. Mr. Williams explained that this rezoning application has been submitted to satisfy a condition of consent. Application File No. B12-18 proposes the severance of a dwelling surplus to a farm operation as a result of a farm consolidation, conditionally approved by the Committee of Adjustment on August 7, 2018. The application proposes to rezone the severed parcel, to a site specific Agricultural Small Holdings Zone and to rezone the lands to be retained to an Agricultural Purposes Only Zone. The subject lands are located southeast side of Century Drive and southwest of Adelaide Road. Surrounding land uses are predominately agriculture in nature. The lands to be severed are

approximately 1.6 acres in size and contain a single detached dwelling, attached garage, two small sheds, a silo and detached accessory building. The remnant parcel contains agricultural land in crop production and a municipal drain appears to cross through the subject lands which are privately serviced. Century Drive is a municipal road under municipal jurisdiction. The application is consistent with Provincial Policy Statement, County Official Plan and Strathroy-Caradoc Official Plan. No comments have been received other than from Director Matt Stephenson regarding a drainage portion for the municipal drain on the property. Staff are recommending approval of this application.

Mr. Williams explained that the this rezoning application has been submitted to satisfy a condition of consent. Application File No. B20-18-19 proposes the severance of a dwelling surplus to a farm operation as a result of a farm

consolidation and was conditionally approved by the Committee of Adjustment on December 4, 2018. This application proposes to rezone the lands to be severed to a site-specific Agricultural Small Holdings Zone and to rezone the lands to be retained to an Agricultural Purposes Only Zone in order to satisfy one of the consent conditions. The lands are approximately 46 acres of agricultural land and located on the southeast corner of Glendon Drive and Glen Oak Road. Surrounding land uses are predominately agricultural in nature with wetlands /woodlands to the north and a CN rail corridor directly adjacent to the southeast property line. Lands to be severed are approximately 1.5 acres in size and contain a single detached dwelling, attached garage and a detached accessory building. The remnant farm parcel contains agricultural land in crop production and the subject lands are privately services. Glen Oak Road is a municipal road and Glendon drive is a county road. The application is consistent with Provincial Policy Statement, County Official Plan and Strathroy-Caradoc Official Plan. No comments have been received. Staff are recommending approval of this application.
